<u>Prob. 6.2.1</u> (a) The zero order fields follow from current continuity and Ampere's law,

<u>Prob. 6.3.4</u> Gauss' law for \overline{B} in integral form is applied to a pill-box enclosing a section of the sheet. The box has the thickness Δ of the sheet and an incremental area A in the plane of the sheet. With C defined as a contour following the intersection of the sheet and the box, the integral law requires that
